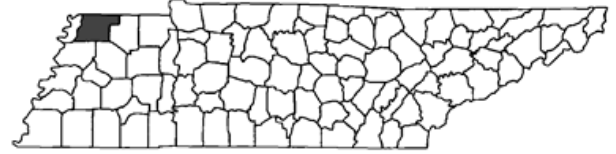

SALARY

Commensurate with training and experience. This position is funded jointly by UT Extension and Obion County. Obion County Government funds 33% of the position salary and benefits costs.

RESPONSIBILITIES:
