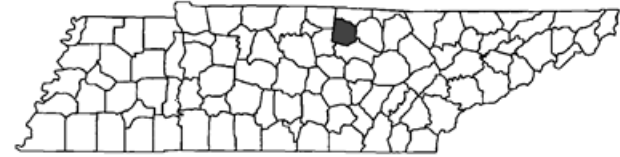

Commensurate with training and experience. This position is funded jointly by UT Extension and Jackson County. Jackson County Government funds 22% of the position salary and benefits costs.
